Recap of the 83rd Session of the Nevada Legislature

Pre-Session: Budget Discrepancy and Swift Resolution

Ahead of the 83rd Legislative Session, Governor Joe Lombardo's administration submitted a proposed executive budget. Shortly thereafter, legislative analysts identified a \$335 million discrepancy, drawing attention to the complex nature of budget forecasting under Nevada's balanced budget requirement. This sparked a broader conversation around fiscal planning and coordination between the executive and legislative branches.

Though initial explanations sought to clarify the issue, the Governor's team took prompt corrective action. By early February, a revised budget was submitted, reflecting updated revenue estimates and technical adjustments. A leadership change within the budget office followed, aimed at ensuring precision and reinforcing public confidence. While the episode prompted scrutiny, it also demonstrated the administration's commitment to accountability and readiness to adapt.

First 100 Days: Navigating Volume, Complexity, and Collaboration

The 83rd Session officially began on February 3, 2025, with lawmakers tackling a historic volume of over 1,000 bill draft requests. Key topics included education, housing, public health, and economic resilience. Despite earnest efforts, the Legislature experienced pressure to process bills efficiently, with nearly 300 measures missing early deadlines due to various factors.

Concerns emerged from transparency advocates regarding public access to deliberations, as some bills advanced quickly to meet procedural constraints. Still, several initiatives progressed with bipartisan support—particularly in budget adjustments and workforce development—demonstrating a collective commitment to serving Nevada's evolving needs, even under tight timelines.

Economic Forum: Fiscal Challenges Met with Pragmatic Adjustments

The May 2025 Economic Forum forecasted a \$173 million reduction in expected general fund revenues, largely driven by moderated trends in gaming and sales tax collections. Legislative and executive leaders responded proactively, working in coordination to ensure that essential programs—such as education, Medicaid, and state employee pay—remained intact.

Through disciplined spending, strategic deferrals, and targeted use of federal relief funds, lawmakers avoided deep cuts. This collaborative effort, involving the Governor's office and legislative fiscal leaders, resulted in the timely passage of five core budget bills. Despite fiscal constraints, the outcome underscored a shared focus on maintaining service delivery and financial stability.

Governor's Priority Legislation: Progress and Foundations for Future Efforts

Governor Lombardo entered the session with an ambitious policy vision, emphasizing school choice, public safety, efficient governance, and housing development. While some proposals faced hurdles due to the realities of divided government, others advanced through negotiation and consensus building.

Broader Legislative Priorities: Cooperation Amid Divergence

Democratic leadership pursued a broad agenda centered on equity, infrastructure, and institutional reform. Many priorities were advanced in tandem with or parallel to the Governor's initiatives, with areas of both agreement and divergence. Among the most impactful:

- Affordable Housing & Tenant Protections
- Behavioral Health & Rural Access
- Labor & Workplace Protections
- Education Accountability & Mental Health
- Environmental Planning

Final Days & Sine Die: Tensions, Compromises, and Procedural Crossroads

The final hours of the 83rd Session were characterized by intense negotiations, late-night votes, and high-stakes decision-making. A major compromise emerged in SB460, integrating components of Governor Lombardo's education reforms alongside Democratic priorities in early childhood education and school safety—an example of bipartisan problem solving under pressure.

A procedural delay led by Senate R"publ'cans, aimed at highlighting concerns about legislative process and policy content, caused several bills to miss final votes. While tensions ran high, the session concluded with substantial legislative output and a shared desire for continued dialogue.

Post-Session Legislative Outcomes

Among the notable bills signed by the Governor:

- AB530: Extended fuel tax indexing
- AB256 & SB28: Promoted regional rail and housing funding
- AB111 & AB321: Public safety enhancements
- SB54, SB353 & AB555: Expanded healthcare services
- SB418: Strengthened charter school oversight
- AB176 & AB235: Protected health and privacy rights
- AB96 & AB104: Supported environmental planning
- SB69 & SB116: Revised governance and tax policies

Looking Ahead: Potential Special Session in Fall 2025

With federal budget negotiations underway, state leaders are monitoring developments that may affect Nevada's fiscal landscape—particularly in healthcare funding. Governor Lombardo's office and legislative leaders are jointly exploring contingency plans, including the potential for a special session in November of 2025. This forward-looking approach reflects a shared commitment to maintaining essential services and adapting to evolving economic conditions.
